CHAIRMAN'S REPORT 2013 - 2014

1. Since the AGM held on the 7th June 2013 there have been Ordinary General Meetings held on the 7th June 2013, the 25th October 2013, the 24th January 2014 and an Extraordinary General Meeting, which was held on the 15th April 2014.

2. Owing to the sad death of Mrs Pelcznski, Mrs Linda Graham was coopted on to the Council in her place.

3. The annual Precept was set at £980.

4. The village finances remained satisfactory with a total of £1346.78 in the savings account and with £211.59 in the current account.

5. A review of our insurance arrangements had been carried out by the Hon Treasurer and approved by the council.

6. The accounts had been approved without comment by the external Auditor.

7. Grass cutting had been carried out under the auspices of Stratford District Council, which has saved the village £75. However the results have not been entirely satisfactory and it is hoped that a better job is made of it next year; if not we will return to our past method of organizing our own contractor.

8. The village website has been redesigned to great effect by Mr S Johnston. Mrs Linda Graham will continue to run it as before.

9. The first part of the Hicks project (the construction of two houses on the NW corner of the village) is practically complete and work has started on the final part with construction of farm buildings on the Long Compton road.

10. Planning proposals by Mr and Mrs Seymour Smith for the building of an Eco House - the Sheds (Application 14/00798/FUL) outside the village boundary on the farm track to the west of the village beyond North Lodge were opposed by the Council by a majority decision of 3 to 1. Members of the public, who attended the EGM, voted 14 to 10 for the Application. It seems that the village is totally divided on this project.

11. I would like to place on record our thanks to the Honorary Treasurer, the Parish Clerk, the Internal auditor and Mr Johnston for the work they have done in the service of our Parish Council during the last year.
