2. The Planning Application: 20/02964/FUL: Proposed erection of single storey rear extension: Leys Farm, Barton on the Heath.

As the response for this application is required by 1st December 2020 it was decided that an Extraordinary General Meeting would be held to discuss this application. The Chairman asked Mr. Edward Hicks what he planned to do. Edward clarified the details of the application and handed over to Mrs. Julia Gotrel, as a resident of Leys Farm, she explained that as the house presently does not have a dining room, the extension would become a dining area adjoining the kitchen. Mr. Julian Mathias asked what materials would be used for this extension, Edward confirmed that it would be stone, glass and oak in keeping with the existing property. Edward was also asked by Mr. Julian Mathias whether he intended to extend the farmhouse in the future, Edward commented that this is not being considered at present. Councillor Juley Piney and Councillor Brian Radford were happy to support the application, along with other Council Members, including members who were absent; Mrs. Gillian Cathie had expressed her support of the application along with The Hon. Treasurer Mrs. Mandy McPherson. The Chairman James Coker will instruct The Clerk to complete the SDC on line form in support of this application.
